2. Narrative report

'Ukrainians Against TB' Public Movement Foundation has completed the implementation of the project 'Public examination of the state of palliative care provision by the Ukrainian state for patients with severe TB forms' supported for financing by Challenge Facility for Civil Society (CFCS) international programme run by the World Health Organisation.

The project's goal is to improve access of patients with end-stage TB to hospice care.

Under the project, the following activities were carried out:

- analysis of Ukraine's regulatory framework governing hospice care provision for patients with end-stage TB;
- analytical examination of the results of hospice care provision for patients with end-stage TB in Ukraine's regions;
- a trip to Sevastopol where meetings were held with officials, doctors and patients of Sevastopol TB Dispensary, with officials of Sevastopol State Administration, Sevastopol City Council and with representatives of NGOs dealing with TB control issues in the Sevastopol region;
- meetings with representatives of the Ukrainian Government to discuss issues concerning improvement of the regulatory framework in order to improve access of patients with end-stage TB to hospice care;
- meetings with people's deputies of Ukraine to discuss issues concerning improvement of Ukraine's legislation in order to improve access of patients with end-stage TB to hospice care;
- proposals were prepared and sent to Ukrainian government bodies about introducing amendments into regulatory documents concerning improvement of access of patients with end-stage TB to hospice care. Based on the results of examination of the proposals submitted, the Cabinet of Ministers of Ukraine issued Instruction of 12 January 2011 No. 77278/1/1-10 to the Ministry of Health of Ukraine about processing of the proposals provided by the Foundation in this area. Also, the Ministry of Health of Ukraine has included a representative of the Foundation in the working group to develop a Concept for the State Programme

on TB Control for 2012-2016 who will advocate use of these proposals in the development of the Concept and the State Programme itself;

- a roundtable was held involving all the stakeholders to discuss proposals about improving access of patients with end-stage TB to hospice care.

In the period from 15 November 2010 to 31 January 2011, working meetings were held where issues were discussed concerning improvement of access of patients with end-stage TB to palliative and hospice care and improvement of the legislative and regulatory framework in this area:

On 24 December 2010, a meeting was held with first deputy Health Minister Bidny Valeriy Grygorovych;

On 12 and 20 January 2011, meetings were held with head of the State Service of Ukraine to Control HIV/AIDS and Other Socially Dangerous Diseases Fedko Oleksandr Anatoliyovych;

On 27 December 2010 and 19 January 2011, meetings were held with head of the Committee to Control HIV/AIDS and Other Socially Dangerous Diseases with the Ministry of Health of Ukraine Cherenko Svitlana Oleksandrivna;

On 28 December 2010 and 11 January 2011, meetings were held with first deputy head of the Committee to Control HIV/AIDS and Other Socially Dangerous Diseases with the Ministry of Health of Ukraine Stelmakh Olga Mykhailivna;

On 27 December 2010 and 14 January 2011, meetings were held with chief specialist of the Committee to Control HIV/AIDS and Other Socially Dangerous Diseases with the Ministry of Health of Ukraine Kovalenko Olga Fedorivna.

As a result of these meetings, an agreement was reached on cooperation between 'Ukrainians Against TB' Public Movement Foundation and the Ministry of Health of Ukraine in improving the regulatory framework in the area of palliative and hospice care provision for patients with end-stage TB.

First of all, this regards joint development of a number of measures to improve access of patients with end-stage TB to be included in a draft Concept for the State Programme on TB Control for 2012-2016 and in the State Programme itself. Also, the Foundation's specialists will be engaged in the development of regulatory acts of the Ministry of Health of Ukraine in this area.

Also, a number of working meetings were held with people's deputies of Ukraine who are members of the Verkhovna Rada Committee on Public Health:

On 22 and 24 December 2010, meetings were held with people's deputy of Ukraine Karpuk Volodymyr Georgiyovych, head of the subcommittee on legal support for medical care, therapeutic activities, medical education and science of the Verkhovna Rada Committee on Public Health;

On 17 December 2010 and 11 January 2011, working meetings were held with people's deputy of Ukraine Sorochynska-Kyrylenko Rayisa Mykolayivna, head of the subcommittee on medical insurance and control over implementation of state programmes in the area of public health of the Verkhovna Rada Committee on Public Health;

On 11 January 2011, a working meeting was held with people's deputy of Ukraine Gaidayev Yury Oleksandrovych, head of the subcommittee on legal support for state policy for public health, pharmacy development and pharmaceutical activities of the Verkhovna Rada Committee on Public Health.

During these meetings, the people's deputies of Ukraine were familiarised with the current situation with hospice and palliative care provision for patients with end-stage TB and with proposals about improving the regulatory framework in this area. Also, 'Ukrainians Against TB' Public Movement Foundation was instructed to prepare materials about the situation with hospice and palliative care provision for patients with end-stage TB for a meeting of the Verkhovna Rada Committee on Public Health.

On 21 December 2010, 'Ukrainians Against TB' Public Movement Foundation organised and held a roundtable 'Public examination of the state of palliative and hospice care provision for patients with severe TB forms in Ukraine'.

At the roundtable, the results were presented of an analytical examination of the state of palliative and hospice care provision for patients with end-stage TB in Ukraine's regions and of an analysis of Ukraine's regulatory framework governing palliative and hospice care provision for patients with end-stage TB.

Also, roundtable participants were familiarised with the experience of palliative care provision in Mykolayiv Oblast and in Sevastopol.

Discussed were proposals about improving the relevant regulatory framework, prospects and future steps to improve access of patients with end-stage TB to palliative and hospice care services.

Roundtable participants supported these proposals and decisions to submit them to the Cabinet of Ministers of Ukraine, the Ministry of Health of Ukraine, the relevant committee of the Verkhovna Rada of Ukraine.

Roundtable materials, analysis of Ukraine's existing regulatory framework governing palliative and hospice care provision for patients with end-stage TB and proposals about its improvement were sent to Prime-Minister of Ukraine M.Ya. Azarov, Health Minister of Ukraine I.M. Yemets, head of the Verkhovna Rada Committee on Public Health, people's deputy of Ukraine T.D. Bakhteyeva, the Finance Ministry of Ukraine, the Cabinet of Ministers of the Autonomous Republic of Crimea, oblast state administrations and Kyiv and Sevastopol state administrations.

4. Have you found a way to go on with the activities you launched using the grant? Please, describe it:

Since the issues raised during the project's implementation concern reformation of the legislation and regulatory framework, which is a lengthy process, the issue of advocacy of the proposals developed has been included in the current plans of 'Ukrainians Against TB' Public Movement Foundation for 2011.

Also, the analysis carried out during the project's implementation has shown that almost all of the currently functioning hospices for patients with TB were opened at the expense of sponsor and donor funds. The Foundation has started work to find donor organisations that could finance part of the costs of the creation of a network of hospices for patients with end-stage TB in all of Ukraine's regions.
