

Workshop to build the capacity of civil society activists, advocates and organizations for people who use drugs to work on TB/HIV

June 10-11, 2010 Liverpool Cathedral St James' Mount Liverpool, UK

WHO and UNAIDS, in collaboration the TB/HIV Working Group of the Stop TB Partnership and a number of civil society partners, is planning a workshop to build the capacity of civil society activists, advocates and organizations for people who use drugs in order to engage them effectively in advocacy for improved access to TB and HIV prevention, diagnosis and treatment services for drug users.

The two day advocacy workshop will familiarize participants with the integrated TB/HIV and harm reduction policy guide (June 10-11, 2010) in Liverpool, UK.

The meeting will have the following specific objectives:

- Introduction to TB and TB/HIV overview of tuberculosis, prevention, treatment and care
- Introduction to the WHO TB/HIV collaborative activities policy and overview of current implementation and challenges including the new ICF/IPT guidelines
- Introduction to the WHO, UNAIDS and UNODC joint policy guide to address the problem
  of HIV associated TB among drug users, and how to catalyze implementation in countries
  with drug use problems which is critical to the health of drug users and contributes
  towards universal access of TB and HIV services for people living with HIV.
- Develop better understanding of the concerns and needs of the community of people who use drugs around TB and HIV and how best to respond to these needs.
- Network with each other and build momentum to catalyze implementation of a fully integrated approach based on the needs of people who use drugs in their countries and regions.
- Discuss strategies to enhance community mobilization for implementation of collaborative TB/HIV and drug user services and demand generation for the services
