



Accelerating Advocacy on TB/HIV

Of the 33.2 million people living with HIV a third are estimated to also be infected with Tuberculosis (TB). TB remains one of the most common causes of illness and is the leading cause of death among people living with HIV, despite being largely curable and preventable. There were an estimated 1.1 million new HIV positive TB patients in 2009, and 380,000 people died of HIV-associated TB. The World Health Organization (WHO) estimates that almost one in four of all HIV deaths is associated with TB. In response, WHO issued a policy for the delivery of integrated TB and HIV services that aims to reduce the burden of TB among people living with HIV and the burden of HIV among TB patients.

The TB/HIV collaborative activities policy outlines 12 steps that national TB and HIV programs must implement in order to respond to TB/HIV co-infection. HIV testing of TB patients has increased substantially over the past 5 years, with 1.7 million tested for HIV in 2009, up from 1.4 million in 2008. However, the *Three 'I's* (intensified case finding for TB, isoniazid preventive therapy (IPT) and infection control) which are measures that reduce the burden of TB in people living with HIV, are still not being implemented. In 2009 globally, only 5% of all people estimated to be living with HIV were screened for TB. The 2010 Global TB report suggested that only 41% of the notified TB patients were tested for HIV in the Region of Americas, ranging as low as 2 to 12% in some countries. TB screening among people living with HIV remains very low and provision of IPT was reported in only 13 countries of the Americas.

HIV civil society is a key conduit to raising awareness of the issues, creating demand and bringing about implementation. However, HIV civil society knowledge of the issues and capacity to effectively engage in advocating for those services which reduce the burden of TB in people living with HIV needs to be enhanced. Previous experience shows that involving civil society is crucial to raise awareness and visibility of the key issues at all levels as well as creating demand for services locally and globally.

Workshop Objectives

The one day advocacy workshop will:

- Facilitate networking opportunities among participants, and translate their experiences/concerns about TB/HIV into advocacy recommendations based on the needs of people in their countries and regions.
- Help participants identify key messages on TB/HIV to advocate for at the subsequent regional meeting.
- Share information on funding opportunities and other resources so that participants can pursue their local/regional TB/HIV advocacy priorities.
