



## Scaling-up the implementation of collaborative TB/HIV activities in the Region of the Americas

### **General Objective:**

To share regional and global experiences and best practices for greater political advocacy, resource mobilization and scale-up in the implementation of collaborative TB/HIV activities and integration of TB and HIV services in the Region of the Americas.

### **Specific objectives:**

1. To share regional and global experience, best practices and lessons learnt to scale-up collaborative TB/HIV activities, integration of TB and HIV services and the multisectoral approach to TB/HIV in the Region of the Americas, strengthening partners' involvement.
