<b>BACKGROUND (INCLUDING PROBLEM STATEMENT):</b>			
<p>The success of the Global Fund replenishment - \$12B over three years - is a bold demonstration of global solidarity and a clear endorsement of the progress and direction of the Global Fund. Given the impact of the Global Fund in the fight against TB and the big gap that still remains, it is critical to support the roll out of the Global Fund's New Funding Model over the next two years.</p> <p>Despite this great achievement, the challenge remains of how to prioritise identified gaps, deliver key TB services that reach the most vulnerable while at the same time demonstrate value for money.</p>

<p>The Executive Secretary of the Stop TB Partnership will be joined by Mark Dybul the Executive Director of the Global Fund and Eliud Wandwalo, the Senior TB Adviser to the Global Fund.
