Governance

Diversity & Inclusion

1. The Diversity & Inclusion Adviser to the Stop TB Partnership Secretariat gave a presentation to the Executive Committee about trainings provided to staff, including three trainings on diversity and inclusion (D&I) for managers. The presentation also focused on training options for Board Members and constituencies for the consideration and advice by the Executive Committee.

The Stop TB Partnership is one of the most advanced organizations in the field of D&I in the global health area, therefore, it would be important to communicate about this part of the work of the Board; reporting about the groundbreaking approach that the Board has taken to ensure that TB-affected voices in countries are visibly and authentically represented, engaged, and heard in leadership and in its governance system.

2. The Executive Committee discussed future D&I trainings for Board members. And about "communication exclusiveness" in terms of how Board members can stay in contact beyond Board meetings, how to grow and nurture these relationships, with regards to the broader Board's Action Plan.

The Adviser to the Board Chair addressed the Executive Committee conveying more information about the preferred location by the Minister of Health of India.
