Shri Narendra Modi, and the commitments and announcements made during the One World TB Summit. The Board highlights the ground-breaking initiatives and plans unveiled by the Prime Minister and Dr Mansukh Mandaviya, Minister of Health and Family Welfare of India during the One World TB Summit.</li> <li>The Board notes the opportunities represented by the hosting of the G20 presidency by several of the TB high-burden countries between 2022-2025: Indonesia, India, Brazil and South Africa. Therefore, the Board calls on G20 support for TB elimination in the statements following Indonesia's G20 presidency call for action on TB financing, the need to develop a vaccine, the experiences on use of digital technology, artificial intelligence, and links between TB and Pandemic Prevention, Preparedness and Response.</li> <li>The Board appreciates India for estimation of TB burden developed with in- country evidence and strong data which reports the TB incidence and</li> </ul>	<ul> <li>Stop TB's Executive Director participated in the first G20 Health working committee meeting in Thiruvananthapuram highlighting the significance of TB in all the three thematic areas- Pandemic preparedness, digital health and one health. Stop TB participated in the C20 meeting and presented the progress made on TB within the context of digital health. The national TB programs and partners participated in the several other G20 related meetings and highlighted TB. The Stop TB Partnership working with partners officially submitted suggestions to include in the outcome document.</li> <li>India included the Varanasi Stop TB Board meeting and related meetings as G20 co-branded meetings. These mobilisations were led by civil society, and brought together Government, MPs, journalists and other TB partners. The Board notes the progress and appreciates the efforts of the Secretariat to address the decision points from the 35th Stop TB Partnership Board meeting.</li> <li>8. The Board acknowledges the Executive Director Report and is appreciative of the entire Secretariat for the commendable work delivered during the past ten months, and welcomes the report shared including on the Key Performance Indicators Results for 2022.</li> <li>9. The Board applauds the pre-Board event of TB Champions hosted by REACH with the support of USAID, and in coordination with the NTEP (National TB Elimination Program of India) and the Stop TB Partnership, an event that brought together 50 TB Champions from across India to strategize, develop and launch the Varanasi Statement on Ending TB. The Board encourages the creation and facilitation of similar spaces for TB-affected community and civil society to participate in country level advocacy, engagement, and governance dialogues.</li> <li>10. The Board applauds the development and launch of The Accountability Report of TB-affected Communities &amp; Civil Society: Priorities to Close the Deadly Divide and highlights the unprecedented levels of engagement with more than one thousand TB affected community and civil society partners engaged and mobilized in the development of this report. The Board wishes to reinforce each of the calls to action from the report and encourages the dissemination and use of this report as part of preparations for the 2023 UN High Level Meeting (UNHLM) on TB.</li> </ul>	<ul> <li>Key Asks for the High-Level Meeting were unpacked and disseminated and a set of shared actions were promoted. These shared national actions were advocacy focused and included: ensuring the highest level representation from respective countries; dissemination of UNPGA invitation to participate; registration for an intervention at the HLM by the country missions; developing a country pledge; reiterating the importance of equitable, rights based B response; securing the position of TB survivors and civil society on country delegations; organising a briefing for the country delegation; elevated ambition across allied countries; adapting the political declaration and its targets and commitments at the country level, in the NSP.</li> <li>The country level meetings were followed up with Mission visits in New York (see sections below).</li> <li>The accountability report of TB affected communities and civil society, <i>A Deadly Divide</i>, was developed with inputs from community partners from 92 countries - an unprecedented exercise of community engagement, led by communities and civil society themselves. The report and accompanying dissemination and communication toolkit is available in English, Spanish, Portuguese, French, Russian and Arabic (still being finalized) The report was disseminated at regional Asia-Pacific, Anglophone Africa, Francophone Africa, Eastern Europe and Central Asia, the Americas and country level. To further advance ownership and advocacy, Challenge Facility for Civil Society supported 22 countries level dissemination events featuring civil society, affected communities, parliamentarians, government, and journalists. These country level engagements ensured that the <i>Deadly Divide</i> messaging and advocacy was framed in light of the United Nations High Level Meeting priorities described in the previous point above.</li> </ul>
36.2	<ol> <li>The Board commends the hard work of the TB teams in India, Indonesia, Brazil, Nigeria and applauds their achievements and welcomes the bold vision for the 2023 UNHLM on TB.</li> <li>The Board applauds the announcement by the Board member from France regarding their new engagement, collaboration, and financial contribution to the Stop TB Partnership Secretariat as a new donor, through L'Initiative, a facility implemented by Expertise France. The Board encourages the Secretariat to work closely with the Government of France, and its operator,</li> </ol>	<ul> <li>STP worked closely and fostered a collaborative partnership with L'Initiative, operated by Expertise France, notably to support Challenge Facility for Civil Society (CFCS) Round 12 operations together with USAID. As result of an open selection process STP is supporting 113 organisations in 38 countries and 6 regions, with USD13.5 million being awarded in grants to initiate, scale up and institutionalise Community, Rights and Gender (CRG) in TB. Strengthening community and civil society capacity to engage in TB is central to its pursuit. Under CFCS Round 12 STP will support 7 countries</li> </ul>



and proceed with the implementation of Challenge Facility of the Civil Society (CFCS) grants together with USAID and other donors to strengthen the capacities of civil society organizations.

- 3. The Board notes the status of TB globally and applauds the remarkable efforts made at the country level in 2022 to recover from the impact of the COVID-19 pandemic including detecting, diagnosing, and treating potentially the highest number ever of people with TB in one year, based on provisional monthly/quarterly notification data reported to WHO for 2022. A special mention to efforts of India, Indonesia, Nigeria and other high burden countries for highest ever TB notification surpassing even pre-COVID-19 levels.
- 4. The Board calls on all countries to follow the END TB Strategy and the Global Plan to End TB 2023-2030 and to develop ambitious national strategic plans, which aim to end TB by 2030, with packages of interventions to reach national targets and to encourage Heads of State and Heads of Governments to deliver ambitious commitments in New York at the 2023 UNHLM.
- 5. Recognizing the impact of the World Health Organization Director-General Flagship Initiative on ending TB in close collaboration with the Stop TB Partnership and the Global Fund, the Board applauds and supports the Flagship Initiative for 2023-2027, that features new targets and an intensified focus on universal access to quality TB prevention and care, on advancing research especially for new vaccines, strengthening multi-sectoral engagement and accountability to address the key drivers of the epidemic and on building linkages with the agendas of universal health coverage, pandemic preparedness and anti-microbial resistance.
- 6. The Board welcomes the Secretariat's proposal to build a Coalition of Leaders to End TB, with the inaugural leadership of the Prime Minister of India, H. E. Shri Narendra Modi, with the aim of bringing Heads of State and Governments of other nations such as Brazil, Indonesia, Nigeria and South Africa, and looks forward to a successful launch in New York during the UN General Assembly (UNGA) week.

(Benin, Burkina Faso, Cameroon Central African Republic, Cote d'Ivoire, Democratic Republic of Congo, and Niger) and 19 organisations, as well as the Regional TB Community Network, DRAFTB in francophone Africa. The Secretariat has also observed an increase in demand for CRG technical assistance (TA) from the region. In addition, STP was part of a steering committee that conceptualised, guided, and selected participants for the TB Masterclass for young researchers from francophone African countries on the challenges in Tuberculosis and made CRG expert from the region available to conduct a session on "Understanding CRG in TB and Operationalization of CRG principles in TB research". STP is working with L'Initiative and SMART4TB to facilitate the translation of

STP is working with L'Initiative and SMAR141B to facilitate the translation of SMART4TB training materials into French and for broader dissemination and use.

- During 2023 several high TB burden countries updated their national strategic plans (NSPs) prior to submission of their Global Fund funding requests. The Secretariat pushed for increased ambition in planning and observed a general increase in the ambition level of NSPs and Global Fund Funding Requests. In its advocacy efforts the Secretariat, along with Partners pushed for ambitious commitments by countries in their UNHLM interventions.
- Stop TB Partnership launched the **Coalition of Leaders** on 19 September 2023 in a high-level event in the UN building in New York on the sidelines of the UN General Assembly. During the high-level event, Ministers of Health from five countries, representing their Heads of State, H.E. Dr Ethel Maciel, Vice-Minister of Health, Brazil; H.E. Budi G. Sadikin, Minister of Health, Republic of Indonesia; H.E Azhar Giniyat, Minister of Healthcare, Government of Kazakhstan; H.E Susan Nakhumicha, Minister of Health, Republic of Kenya; H.E. Teodoro Herbosa, Secretary of Health, Republic of South Africa and Professor Tumani Nagu, Chief Medical Officer, Ministry of Health, United Republic of Tanzania shared their countries progress on the TB response, enabled and powered by their president's vision, leadership and specific initiatives. Each of the Ministers of Health, representing their leaders, emphasized the agreement of their Presidents to be part of the



		Coalition and continue to champion the TB cause at the national, regional and global level towards ending TB.

Lung Health, ASLM (African Society of Lab Medicine) etc.
<ul> <li>Innovations and Public -Private partnership: <u>TB Innovation Summit 3.0</u> (TBIS</li> </ul>
3.0) facilitated the development of a new partnership for innovative
screening and program delivery. Qure.ai and Biospectal will collaborate to
bundle their innovative technologies for integrated service delivery for the
first point of care to screen for multiple findings. Qure.ai's tool qXR can
detect the risk of heart failure on chest X-rays which can be added by
findings detected by Biospectal's tool OptiBP to triage for hypertension and
cardiovascular diseases. This would strengthen the capacity of the frontline
health workers in low-resource settings, as well as optimize the resources
for triaging, diagnosis and further referral with reduced turnaround time in
the absence of specialist doctors.
• The <u>RTC initiative</u> launched a <u>Funding Opportunities Database</u> for our
countries' stakeholders and partners to facilitate new and/or additional
funding opportunities that could further support current projects or their
efforts to pursue future opportunity areas. We hope some of these funding
opportunities, similar to the recent grant agreement signed between the
RIGHT Foundation and FIT, could <b>build upon the catalytic funding provided</b>
by the various Stop TB Partnership's initiatives including, Challenge Facility
for Civil Society, TB REACH, etc.

## Stop B Partnership

- The Board commends the leadership of the two Co-facilitators, H.E. Krzysztof Szczerski, Permanent Representative of Poland to the United Nations, and H.E. Bakhtiyor Ibragimov, Permanent Representative of Uzbekistan, and the work of the Stop TB Partnership Secretariat, the World Health Organization, the President of the UN General Assembly, the Affected Communities and Civil Society Hub hosted by GFAN, the UNHLM on TB Partners Group, and the many others that are working towards ensuring a successful 2023 UNHLM on TB.
  - 2. The Board notes the unanimous adoption of the General Assembly resolution A/77/L.51 "Scope, modalities, format and organization of the high-level meeting on the fight against tuberculosis" (the Modalities Resolution), and congratulates H.E. Krzysztof Szczerski and H.E. Bakhtiyor Ibragimov, as well as all UN member states, for the work done to ensure a comprehensive and strong Modalities Resolution.
  - 3. The Board requests the Secretariat to continue ensuring a strategic and coordinated approach through the end of September 2023 and to assess limitations and resources necessary to successfully prepare the 2023 UN General Assembly declaration.
  - 4. The Board welcomes the ongoing work done by the World Health Organization, with support from Stop TB Partnership and other partners, to support the Secretary-General with the development of a progress report focusing on the comprehensive review of progress towards the achievement of global TB targets and implementation of the 2018 Political Declaration of the UNHLM on TB.
  - 5. The Board notes the inputs from the UHC 2030 and Pandemic Action Network on the roles and vision of the UNHLMs on Universal Health Coverage (UHC) and Pandemic Prevention, Preparedness, and Response (Pandemic PPR) and asks the Secretariat, working with the World Health Organization and all partners to continue collaboration towards three very successful UNHLMs on health in September 2023.
  - 6. The Board thanks the African Union for the offer of their institutional mechanism for advocacy and convening of African countries and requests the Secretariat to work with the African Union and other similar institutions such as the Association of Southeast Asian Nations (ASEAN) to ensure that the TB affected countries in their membership are mobilised for active participation in the UNHLM on TB, including the participation of Heads of States/Governments.

- Stop TB Partnership engaged with stakeholders working on the UN HLMs on Universal Health Coverage (UHC) and Pandemic Prevention, Preparedness and Response (PPPR) to ensure alignment, through development of briefs on TB and PPPR (available <u>here</u>), being part of preparatory webinars organized on UHC UNHLM by UHC2030 and attendance of some of the negotiations on their respective political declarations.
- The Secretariat continued to work with the African Union and ASEAN. African Union became a member of the Stop TB Partnership Board and some events on TB are being planned in Africa in we are in the process of establishment of formal engagement with the African Union.
- A project on Airborne Infection Defence Platform (AIDP) has been initiated with the ASEAN Secretariat. To facilitate advocacy efforts the country dashboards on Stop TB website now have aggregated views for ASEAN and African Union countries.
- Stop TB Partnership partnered with WHO and engaged with the UN PGA office to ensure that all stakeholders, particularly the TB-affected communities can participate in the multi-stakeholder consultations and a diverse group of voices are included in the agenda. Stop TB Partnership supported the travel and participation of a number of civil society partners from high burden countries. Stop TB Partnership did outreach to UN missions in New York and continued to have engagement with the Cofacilitators.
- Preceding the Multi Stakeholders hearing in NY, the Secretariat finalised and published the Key Asks for UNHLM following a very inclusive process of consultations including an open web-based feedback survey. Stop TB Partnership, the Civil Society Platform for UNHLM and Partners used the document to advocate for stronger language and commitments in the successive drafts of the UNHLM political declaration. The Key Ask documents can be hound <u>here</u>.



- 7. The Board also encourages all Board members, partners and UN Member States to develop and announce ambitious new pledges and commitments in the lead up to or at the UN HLM on TB in September 2023
- 8. The Board strongly encourages member states to ensure that all key TB constituents, as listed in the Modalities Resolution, have the opportunity to participate and have their voices heard at the Multi-stakeholder Hearing on TB taking place on 8-9 May in New York. The Board requests the President of the General Assembly, working with the Secretariat and the World Health Organization, to approve registrations as soon as possible to facilitate attendance.
  - i. The Board welcomes the Stop TB Partnership Secretariat's plan to conduct outreach to UN missions in New York, with participation of representatives of TB-affected communities, members of parliaments, and researchers, prior to the Multi-stakeholder Hearing in May 2023
  - The Board also requests UN Member States to attend the Multistakeholder Hearing and ensure the discussions and priorities of civil society are considered in the development of the Zero Draft for the UNHLM Political Declaration.
- 9. The Board supports the draft 'UNHLM Key Asks from TB Stakeholders and Communities' and notes the ongoing consultations to ensure the document is comprehensive and represents the priorities of the global TB community.
  - i. The Board requests UN Member States to consider this document in the development of the Zero Draft for the UNHLM on TB Political Declaration
  - iii. The Board requests that Board members and partners engage in the process of national, regional, and global consultations on the Key Asks.
- 10. The Board urges all Board members and partners to work with their networks to ensure through all means possible that Heads of State and Heads of Government attend the UNHLM on TB and bring forward powerful plans and commitments. The Board strongly calls for inclusion of representatives of TB-affected communities and civil society in their national delegations to the 2023 UNHLM on TB.
- 11. The Board asks the Secretariat to work with Board members and partners to coordinate efforts of partners for the side events organized during the UNGA in New York. The Board requests that these side events be aligned and build on each other to ensure high-level visibility of the TB epidemic during the UNGA week.

• Following the Board guidance a number of side events were organized by Stop TB Partnership in collaboration with other partners and countries. A list of all side events on TB during the UNGA week can be found <u>here</u> with the names of the organizing partners. The side events were very visible and created a strong momentum for TB advocacy around the UNGA. Several announcements were made in these side events, including some exciting price reduction announcements in TB drugs and diagnostics. - Stop TB Partnership has worked closely with the Global Fund to ensure that the high burden countries not only get their full allocation of funds but are able to access additional funds from C19RM for dual purpose tools that can benefit both TB and Covid19/pandemic preparedness.
- **C19RM** PO Wave 2 had investment of 1.9 billion USD, 11% of that went towards HIV, TB, Malaria mitigation. Lab systems had 342 million USD that included digital X-Rays and molecular testing machines as part of strengthened integrated multi disease testing and screening platforms with approximately USD 120 million. This will further strengthen TB screening and testing.
- Pandemic Fund call for proposals had 3 priority areas, all of them can be of use in TB response- Surveillance system strengthening, Laboratory and diagnostics, Human Resources for health and community system strengthening.

Current status of Pandemic Fund:

- USD 2 billion raised, awarded first round totalling USD 338 million for 37 countries, catalysing USD 2 billion additional resources (16 single country and 3 multi country grants).
- There is complementarity between Pandemic fund investments and C19RM investments at country level.

Stop TB had developed a note to help countries to include activities that also benefits the TB response in countries.

- Stop TB Partnership is implementing **Short Term Technical Assistance** (STTA) Programme with funding support from USAID and TA focussing Francophone countries with funding support from L'initiative/Expertise France. Roster of consultants are being expanded to cover all technical areas.
- Stop TB Partnership has done advocacy with Global Fund and World Bank for blended financing (loan plus grants) to high burden countries such as Bangladesh, Nigeria and Philippines.
