Q&A ITB-Iplus/GDF-MED/2023/2

Q1: Our packaging approved by ERP and submitted to WHOPQ is Pack of 3 alu-alu strips x 28 tablets. Kindly clarify if it is acceptable.

A1: The Alu-Alu packaging of a strip and/or blister foil as approved by the regulator is acceptable for this product.

Q2: We request your kindly clarification on the process for allocation for quantities since there is no specific ratio of allocation viz: 50:50 or 60:40 in the tender document. This would help us to estimate the potential quantities that could be procured and accordingly factor the same while arriving at our bid price.

A2: Please refer to clause 3.9.4

Q3: As per the clause 1.4 the deadline to submit the tender is 04-07-2023 which is too short, so we request you to please extend the deadline?

A3: Considering the technical information readily available in CDP, the deadline given is adequate for tender submission for a single product and it will not be extended.

Q4: As per clause 2.1.5 b – Please confirm do we have to submit any documents for environmental sustainability?

A4: Not required.

Q5: As per clause 2.2.6 request you to please share 21 countries which represent 80% of the total value of TB medicines for Drug-resistant TB (SLDs) and/or TB medicines for Drug-susceptible TB (FLDs) delivered (class A countries).

Q6: In the CDP portal the GDF ceiling quantity in basic units of FPP for regular quantity is mentioned as "672000 tablets", please confirm do we have to consider the same while giving the lead time in CDP portal.

A6: Yes. Please do consider the same while giving the lead time in CDP portal.





Q7: As per clause 3.8.7 "The competitive range of the Bids quoted is considered to be within a maximum delta of +15% from the average price of all eligible products of the same Bid Item. Suppliers that quote a price per unit that falls outside of the competitive range may still be awarded LTAs." How is the above mentioned clause 3.8.7 applicable, if you have decided not to do any allocation?
